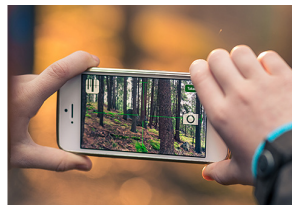

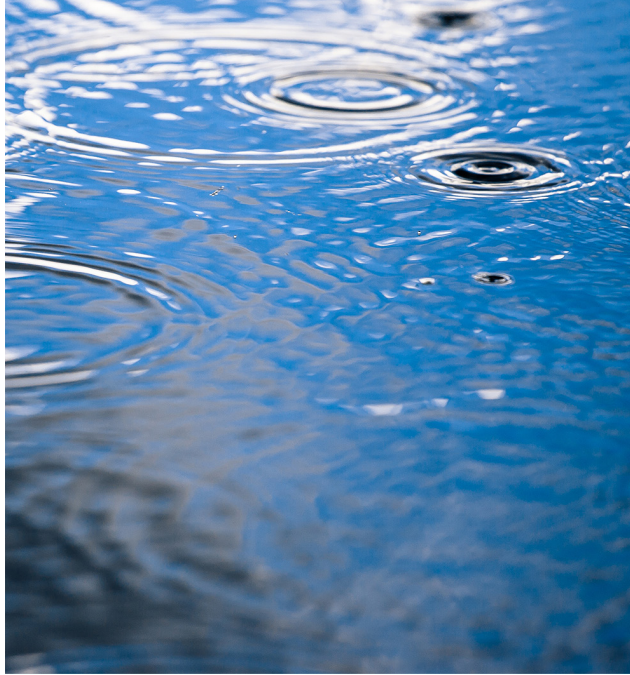
A renewable and sustainable natural resource economy will increase wellbeing and replace the use of non-renewable raw ingredients and energy sources.
