1.1.1 *Minor superficial injuries.* Do not require medical treatment. Relative to the nature of the injury, cause insignificant temporary harm for less than 2 weeks. No permanent harm. - 200 €

1.1.2 *Moderate superficial injuries.* Do not require medical treatment. Relative to the nature of the injury, cause moderate temporary harm for 2–3 weeks. No permanent harm. - 500 €

1.1.3 *Severe superficial injuries.* Do not require medical treatment. Relative to the nature of the injury, cause very serious temporary harm for 3–4 weeks. No permanent harm. 500 - 1 500 €

1.2.1 *Superficial wound (abrasion).* Damage only to the most superficial skin layer (epithelium). No sutures needed. Causes temporary harm for less than 2 weeks. No permanent harm. - 400 €

1.2.2	<i>Clean wound.</i> No discernible damage to subepithelial tissue. Requires sutures, but no particular repair of subepithelial tissue. Causes temporary harm for 2–3 weeks. Possibility of minor permanent harm.	400 – 1 000 €
1.2.3	<i>Jagged wound or wound of subepithelial tissue.</i> Wound not involving damage to nerves, muscles or tendons. Requires repair of subepithelial tissue or the excision of the jagged edges of the wound and may require daily medical treatment for infection. Causes temporary harm for 3–6 weeks. Possibility of permanent harm.	1 000 – 2 000 €

1.3.1	<i>Minor injury of muscle or tendon.</i> Does not require medical treatment. Relative to the nature of the injury, causes insignificant temporary harm for less than 4 weeks. No permanent harm.	200 – 800 €
1.3.2	<i>Moderate injury of muscle or tendon.</i> Intramuscular haematoma requires an incision to the epimysium or the removal of the haematoma by puncturing. Relative to the nature of the injury, causes moderate temporary harm for 2–4 weeks. No permanent harm.	1 000 – 3 000 €
1.3.3	<i>Severe injury of muscle or tendon.</i> Requires surgical treatment. Relative to the nature of the injury, causes very serious temporary harm for 1–3 months. Possibility of permanent harm.	3 000 – 6 000 €

1 000 – 3 000 €

1.4.3 *Severe nerve injury*. Requires long hospitalisation and several reconstructive operations. Relative to the nature of the injury, causes very serious temporary harm for 3 months – 2 years. Permanent harm.

	1.6.1 <i>Minor burn or corrosion.</i> Does not require medical treatment. Relative to the nature of the injury, causes insignificant temporary harm for less than 2 weeks. No permanent harm.	200 – 800 €
	1.6.2 <i>Moderate burn or corrosion.</i> Requires hospitalisation. Relative to the nature of the injury, causes moderate temporary harm for 2–4 weeks. No permanent harm.	1 000 – 4 000 €
	1.6.3 <i>Severe burn or corrosion.</i> Requires long hospitalisation and several reconstructive operations. Relative to the nature of the injury, causes very serious temporary harm for 3–12 months. Permanent harm.	4 000 – 18 000 €

	1.7.1 <i>Minor gunshot wound.</i> Does not require medical treatment. Relative to the nature of the injury, causes insignificant temporary harm for less than 2 weeks. No permanent harm.	400 – 800 €
	1.7.2 <i>Moderate gunshot wound.</i> No extensive tissue damage. Requires the cleaning of the wound and, possibly, the treatment of intramuscular bleeding. Relative to the nature of the injury, causes moderate temporary harm for 2–6 weeks. No permanent harm.	1 000 – 4 000 €

	1.7.3 <i>Severe gunshot wound</i> . Serious tissue damage (skin, nerve, blood vessel, internal organ, bone). Requires long hospitalisation and several reconstructive operations. Relative to the nature of the injury, causes very serious temporary harm for 3–6 months. Permanent harm.	8 000 – 18 000 €

2.1	Fracture of vault of skull ICD S02.0 <i>Fracture of vault of skull</i> . No serious intracranial injuries. Does not require medical treatment, except for possible repair of damage to scalp. Causes temporary harm for 1–2 weeks. No permanent harm.	500 – 1 500 €
2.2	Fracture of base of skull ICD S02.1 <i>Fracture of base of skull</i> . No serious intracranial injuries. Does not require medical treatment, except for possible repair of damage to scalp. Causes temporary harm for 3–4 weeks. No permanent harm.	1 000 – 4 000 €
2.3	Fracture of nasal bone ICD S02.2	
	2.3.1 <i>Stable fracture of tip of nasal bone (os nasale), in good position</i> . Does not require setting. Causes temporary harm for 1–2 weeks. No permanent harm.	300 – 600 €
	2.3.2 <i>Fracture of nasal bone</i> . Requires setting. Causes temporary harm for 3–4 weeks. Possibility of slight permanent harm.	600 – 1 800 €
	2.3.3 <i>Fracture of base of nasal bone or nasal cartilage</i> . Requires surgery. Causes temporary harm for 4–6 weeks. Permanent harm.	1 800 – 2 500 €

2.4	<p>Fracture of malar or maxillary bone</p> <p>ICD S02.4</p> <p>2.4.1 <i>Stable fracture of maxillary bone, in good position.</i> Does not require surgery. Causes temporary harm for 1–3 weeks. No permanent harm.</p> <p>2.4.2 <i>Displaced fracture of cheekbone or zygoma.</i> Requires surgery. Causes temporary harm for 1–4 weeks. Possibility of slight permanent harm (nerve injury, reduced eye mobility).</p> <p>2.4.3 <i>Crush fracture of upper jaw (Le Fort I–III).</i> Requires surgery. Causes temporary harm for 1–3 months. Possibility of permanent harm (reduced oral mobility, trouble biting or chewing).</p>	<p>500 – 1 500 €</p> <p>1 500 – 2 500 €</p> <p>3 500 – 8 000 €</p>
2.5	<p>Fracture of mandible</p> <p>ICD S02.6</p> <p>2.5.1 <i>Stable fracture of mandible, in good position.</i> Requires immobilisation of the jaw. Causes temporary harm for 4–6 weeks. No permanent harm.</p> <p>2.5.2 <i>Displaced unstable fracture of mandible.</i> Requires surgery and immobilisation of the jaw. Causes temporary harm for 4–8 weeks. Permanent harm (malocclusion, wear of the temporomandibular joints).</p> <p>2.5.3 <i>Displaced very unstable compound fracture of mandible.</i> Requires surgery and immobilisation of the jaw. Causes temporary harm for 6 weeks – 3 months. Permanent harm (malocclusion, wear of the temporomandibular joints).</p>	<p>1 500 – 2 500 €</p> <p>2 500 – 4 000 €</p> <p>4 000 – 8 000 €</p>
2.6	<p>Sprain, strain or dislocation of jaw</p> <p>ICD S03.0, S03.4</p> <p><i>Simple sprain, strain or dislocation of jaw.</i> No damage internal to the temporomandibular joint. Does not require medical treatment, except for possible setting. Causes temporary harm for 1–3 weeks. No permanent harm.</p>	<p>400 – 1 000 €</p>

2.7	Fracture of orbital floor ICD S02.3 <i>Fracture of orbital floor.</i> May involve contusion of the eyeball. May require surgery. Causes temporary harm (vision, reduced eye mobility, symptoms of cutaneous nerves) for 2–6 weeks or up to 3 months. Possibility of permanent harm.	1500 – 3 500 €
3	Tooth injuries	
3.1	Dislocation of tooth ICD S03.2	
	3.1.1 <i>Concussion and subluxation of tooth.</i> Tooth loose in its socket, but not displaced. Possible treatment by splinting the affected tooth to adjoining teeth for 2–3 days. Causes temporary harm for 1–2 weeks. No permanent harm.	300- 1 000 €
	3.1.2 <i>Displacement of tooth</i> (luxation, intrusion, extrusion). Requires repositioning and splinting the affected tooth to adjoining teeth for 2–6 weeks. Causes temporary harm for 2–6 weeks. Possibility of permanent harm.	500 – 1 500 €
	3.1.3 <i>Avulsion of tooth</i> (exarticulation). Requires reimplantation and splinting the affected tooth to adjoining teeth for 3–4 weeks. Causes temporary harm for 4–6 months. Possibility of permanent harm.	1 000 – 3 000 €
3.2	Fracture of tooth ICD S02.5	
	3.2.1 <i>Fracture of tooth enamel or crown.</i> Does not reach core of tooth. Requires filling. Causes temporary harm for 1–2 weeks. No permanent harm.	200 – 1 000 €

3.2.2	<i>Fracture of tooth crown or root.</i> Reaches core of tooth. Requires root canal treatment. Fracture of tooth root requires also the splinting of the affected tooth to adjoining teeth for 3 months. Causes temporary harm for 1–3 months. Possibility of permanent harm (loss of tooth).	1 000 – 2 500 €

4.1	Brain injuries

4.1.1	<i>Very minor brain injury</i> (concussion). At most momentary unconsciousness. Does not require medical treatment. Causes temporary harm for a few days. No permanent harm.	400 – 800 €
4.1.2	<i>Minor brain injury.</i> Unconsciousness for at most 30 minutes. Treatment according to symptoms. May cause temporary harm for 1–3 months. Memory loss of at most 24 hours post-injury (PTA, post-traumatic amnesia). No permanent harm.	1 000 – 3 000 €
4.1.3	<i>Moderate brain injury.</i> Unconsciousness of over 30 minutes, but at most 24 hours. Memory loss of more than 7 days. Requires hospitalisation. Causes temporary harm for up to 6 months, sometimes longer than that. Possibility of permanent harm.	4 000 – 9 000 €
4.1.4	<i>Severe brain injury.</i> Often involves intracranial bleeding or haematoma (intracerebral and extracerebral haemorrhaging) that cannot be fully corrected with surgery. Involves unconsciousness for more than 24 hours. Memory loss of more than 7 days. Requires long hospitalisation and rehabilitation. Causes temporary harm for 3–12 months. Permanent harm.	12 000 – 25 000 €

4.2.1	<i>Intracranial bleeding</i> . No severe bleeding. No severe brain injury. Surgical treatment mainly for extracerebral bleeding. Temporary harm for 2–6 months. No permanent harm.	2 500 – 7 000 €
4.2.2	<i>Severe intracranial bleeding</i> . Extensive bleeding. Possibility of serious brain injury. Normally requires surgery. Causes temporary harm for 6 months – 1 year. Possibility of permanent harm.	12 000 – 25 000 €
5	Eye and ear injuries	
5.1	Eye injuries

5.1.1	<i>Contusion of eyelid and conjunctiva</i> . (“black eye”). Does not require medical treatment. Causes temporary harm for 1–3 weeks. No permanent harm.	200 – 500 €
5.1.2	<i>Contusion of eyeball or orbital tissue</i> . Bleeding into the anterior chamber of the eye (hyphaema). Possibility of rebleeding. Requires hospitalisation for the examination of intraocular damage. Treatment with cycloplegic and anti-inflammatory eye drops. Causes temporary harm for 2–6 weeks. Possibility of permanent harm.	500 – 1 500 €
5.1.3	<i>Superficial wound of conjunctiva, cornea or sclera</i> . Non-penetrating injury. Requires patching for 1–5 days. Causes temporary harm for 1–2 weeks. No permanent harm.	400 – 1 200 €
5.1.4	<i>Penetrating wound of conjunctiva, cornea or sclera</i> . Damage to internal layers of the eye. Requires hospitalisation. Causes temporary harm for 2 weeks – 4 months. Possibility of permanent harm.	1 500 – 3 000 €

	5.1.5 <i>Laceration or rupture of eyeball.</i> No prolapse or loss of intraocular tissue. Requires hospitalisation. Causes temporary harm for 2 weeks – 4 months. Possibility of permanent harm.	1 000 – 3 500 €
5.2	Rupture of ear drum ICD S09.2 <i>Traumatic rupture of ear drum.</i> May require lifting of the edge of the ear drum. Causes temporary harm for 2–4 weeks. No permanent harm.	500 – 1 500 €
6	Injuries to the thorax	
6.1	Fracture of rib(s) ICD S22.3, S22.4, S22.5	
	6.1.1 <i>Simple rib fracture</i> (1–2 ribs). Does not require medical treatment. Causes temporary harm for 2–4 weeks. No permanent harm.	800 – 1 500 €
	6.1.2 <i>Multiple rib fracture.</i> No significant lung injury. Requires short hospitalisation for a few days and possibly treatment of haemothorax or pneumothorax with a chest tube. Causes temporary harm for 2–4 weeks. No permanent harm.	1 000 - 2 500 €
	6.1.3 <i>Serial rib fracture and flail chest.</i> Requires hospitalisation for several weeks. Thorax supported for the duration of ventilator treatment; normally also initial treatment of haemothorax or pneumothorax with a chest tube. Causes temporary harm for 2 weeks – 3 months. Possibility of permanent harm (intercostal nerve pain, thoracic deformity, formation of connective tissue in lung tissue).	2 500 – 5 000 €
6.2	Fracture of sternum ICD S22.2 <i>Fracture of sternum.</i> Treatment according to symptoms (pain medication). Causes temporary harm for 1–3 weeks. No permanent harm.	800 – 1500 €

7	Injuries of upper limb	
7.1	Dislocation of shoulder joint and tear of the rotator cuff of shoulder	
	ICD S43.0, S46.0	
	7.1.1 <i>Dislocation of shoulder joint.</i> Requires a sling for 3 weeks. Causes temporary harm for 3–6 weeks. May make the joint susceptible to recurring dislocations; this can be corrected by surgery.	1 000 – 2 000 €
	7.1.2 <i>Simple tear of rotator cuff.</i> Sprains and partial tears susceptible to conservative treatment. Does not require hospitalisation. Physical therapy often necessary. Causes temporary harm for 6 weeks – 3 months. No permanent harm.	1 000 - 2 000 €
	7.1.3 <i>Extensive tear of rotator cuff.</i> Often requires surgery and subsequent physical therapy. Causes temporary harm for 3–6 months. Possibility of minor permanent harm.	2 000 – 3 500 €
	7.1.4 <i>Tear of rotator cuff with collateral injuries.</i> Extensive tears combined with collateral injuries, such as labrum or nerve damage and proximal fractures. Requires surgery. Probability of permanent harm.	3 500 - 5 500 €
7.2	Dislocation of acromioclavicular joint	
	ICD S43.1	
	7.2.1 <i>Dislocation of acromioclavicular joint.</i> Requires a sling for 3 weeks. Relative to the nature of the injury, causes at most moderate temporary harm for 1–3 weeks. No permanent harm.	1 000 – 1 500 €
	7.2.2 <i>Severe dislocation of acromioclavicular joint.</i> Requires surgery and a sling for 6 weeks. Relative to the nature of the injury, causes very serious temporary harm for 1–2 months. Possibility of permanent harm.	2 000 - 3 000 €

7.3	<p>Fracture of clavicle</p> <p>ICD S42.0</p> <p>7.3.1 <i>Simple fracture of clavicle.</i> Requires a sling for 3 weeks. Causes temporary harm for 1–3 weeks. No permanent harm.</p> <p>7.3.2 <i>Significantly displaced fracture of clavicle.</i> Requires surgery and a sling for 3 weeks. Causes temporary harm for 4–8 weeks. No permanent harm.</p> <p>7.3.3 <i>Displaced, compound fracture of clavicle.</i> Proximal injuries (nerve or blood vessel injury). Requires surgery and a sling for 3 weeks. Causes temporary harm for 3–6 months. Possibility of permanent harm.</p>	<p>1 000 – 2 000 €</p> <p>2 000 - 3 000 €</p> <p>3 000 – 6 000 €</p>
7.4	<p>Fracture of humerus</p> <p>ICD S42.2, S42.3, S42.4</p> <p>7.4.1 <i>Simple fracture of humerus.</i> Requires a cast for 6 weeks and binding to the torso. Causes temporary harm for 6–8 weeks. No permanent harm.</p> <p>7.4.2 <i>Significantly displaced fracture of humerus.</i> Requires surgery. Causes temporary harm for 6–12 weeks. No permanent harm.</p> <p>7.4.3 <i>Severe fracture of humerus.</i> Proximal injuries (damage to radial nerve). Normally requires surgery and sometimes also a nerve release operation. Causes temporary harm for 1–6 months. Possibility of permanent harm.</p>	<p>1 500 - 2 500 €</p> <p>2 500 - 4 000 €</p> <p>4 000 – 6 000 €</p>
7.5	<p>Fracture of forearm</p> <p>ICD S52.0, S52.1, S52.2, S52.3, S52.4, S52.5, S52.6, S52.7, S52.8, S52.9</p> <p>7.5.1 <i>Common wrist fracture.</i> Non-displaced fracture of the lower end of radius. Requires a cast for 4–5 weeks. Causes temporary harm for 6–8 weeks. No permanent harm.</p>	<p>1 000 – 2 000 €</p>

	7.5.2 <i>Fracture of forearm.</i> Requires surgery. Relative to the nature of the injury, causes at most moderate harm for 6–8 weeks. No permanent harm.	1 500 – 2 500 €
	7.5.3 <i>Severe fracture of forearm.</i> Proximal injuries (damage to radial nerve) or significant compoundness. Requires surgery. Causes very serious temporary harm for 1–6 months. Possibility of permanent harm.	4 000 – 6 000 €
7.6	Fracture of navicular bone of hand ICD S62.0	
	7.6.1 <i>Fracture of navicular bone of hand.</i> Requires a cast for 6–8 weeks. Causes temporary harm for 3–4 months. No permanent harm.	1 500 – 2 500 €

If there is a need to base the assessment on some external compensatory regime, *reference* may be made to the Norms and Guidelines of the Traffic Accident Board or to the Disability Category Compensation Levels under the Workers' Compensation Act.
