#### Abstract

The Government Action Plan sets out the main objectives and measures for the strategic themes of the Government Programme, along with the timetables for these and the names of the ministries responsible. The objectives and measures reach across ministerial boundaries. The plan is broadly structured in the following way:

**Finland as a sustainable economy.** The aim of economic policy is to increase wellbeing and prosperity. This means ecologically and socially sustainable economic growth, high employment and sustainable public finances.

**Carbon neutral Finland that protects biodiversity.** Carbon neutrality will be pursued with emissions reduction measures and carbon sinks. New legislation on nature conservation will protect diversity.

**Globally influential Finland.** The promotion of human rights, the rule of law, democracy, peace, freedom, tolerance and equality is central to Finland's foreign and security policy. The Paris Agreement and the 2030 Agenda for Sustainable Development form the foundation for global cooperation.

**Safe and secure Finland built on the rule of law.** Finland must ensure internal and external security, respect for the rule of law, and people's everyday safety and security.

**Dynamic and thriving Finland.** Finland aims to be a global leader in skills and innovation. International growth and a strong entrepreneurship policy can diversify business structures and create opportunities for sustainable growth.

**Finland built on trust and labour market equality.** Improving business competitiveness is essential and must focus on employee education and skills, product development and investment, services that seek to boost employment, and incentives for entrepreneurship and self-employment.

**Fair, equal and inclusive Finland.** The core of the welfare model consists of non-discrimination, services in health and wellbeing, social mobility and civil society.

**Finland that promotes competence, education, culture and innovation.** A rise in the level of education and competence, a reduction in the differences in learning outcomes, and an increase in educational equality will be sought at all educational levels. The measures taken will concern the entire education system and its future development. A strong focus will also be placed on improving the research, development and innovation environment.

#### Tiivistelmä

Hallituksen toimintasuunnitelmassa on hallitusohjelman strategisten kokonaisuuksien keskeiset poikkihallinnolliset tavoitteet ja toimenpiteet sekä vastuutus ja aikataulut. Jäsennys:

**Kestävä talous.** Talouspolitiikan päämääränä on hyvinvoinnin lisääminen: ekologisesti ja sosiaalisesti kestävä talouskasvu, korkeaa työllisyys ja kestävä julkinen talous.

**Hiilineutraalius ja luonnon monimuotoisuus.** Hiilineutraaliutta tavoitellaan päästövähennystoimilla ja hiilinieluilla. Monimuotoisuutta turvaa uusi luonnonsuojelulainsäädäntö.

**Suomi kokoaan suurempi maailmalla.** Ulko- ja turvallisuuspolitiikassa keskeistä on ihmisoikeuksien, oikeusvaltioperiaatteen, demokratian, rauhan, vapauden, suvaitsevaisuuden ja tasa-arvon edistäminen. Pariisin ilmastosopimus ja Agenda 2030 ovat perustana kansainväliselle yhteistyölle.

**Turvallinen oikeusvaltio.** Suomen on huolehdittava sisäisestä ja ulkoisesta turvallisuudesta, oikeusvaltioperiaatteen noudattamisesta ja arjen turvasta.

**Elinvoimaisuus.** Tavoitteena on Suomi kansainvälisen osaamisen ja innovaatioiden kärkimaana. Kansainvälinen kasvu ja vahva yrittäjyyspolitiikka monipuolistavat elinkeinorakennetta ja luovat kestävän kasvun edellytyksiä.

**Luottamus ja tasa-arvoiset työmarkkinat.** Olennaista on yritysten kilpailukyvyn parantaminen ottaen huomioon työntekijöiden koulutus ja osaaminen, tuotekehitys ja investoinnit sekä työllistämiseen tähtäävät palvelut ja yrittäjyyteen kannustaminen.

**Oikeudenmukaisuus ja yhdenvertaisuus.** Hyvinvointimallin ydintä ovat yhdenvertaisuus, hyvinvointi- ja koulutuspalvelut, sosiaalinen liikkuvuus ja kansalaisyhteiskunta.

**Osaamisen, sivistyksen ja innovaatioiden Suomi.** Koulutus- ja osaamistason nousua, oppimiserojen kaventumista ja koulutuksellista tasa-arvoa tavoitellaan kaikilla kouluasteilla. Keinot kohdistuvat koko koulutusjärjestelmään ja sen kehittämiseen. TKI-toimintaympäristön parantamiseen panostetaan.

#### Referat

I regeringens handlingsplan ingår centrala förvaltningsövergripande mål och åtgärder för de strategiska helheterna i regeringsprogrammet samt ansvar och tidtabeller. Disposition:

**En hållbar ekonomi.** Målet för den ekonomiska politiken är att öka välfärden: en ekologiskt och socialt hållbar ekonomisk tillväxt, en hög sysselsättning och en hållbar offentlig ekonomi.

**Klimatneutralitet ja biologisk mångfald.** Koldioxidneutralitet eftersträvas genom utsläppsminskningsåtgärder och kolsänkor. Mångfalden tryggas genom den nya naturvårdslagstiftningen.

**Finland – större än sin storlek i världen.** Det centrala för utrikes- och säkerhetspolitiken är arbete för de mänskliga rättigheterna, rättsstatsprincipen, demokrati, fred, frihet, tolerans och jämställdhet. Klimatavtalet från Paris och Agenda 2030 utgör grunden för det internationella samarbetet.

**En trygg rättsstat.** Finland måste se om sin inre och yttre säkerhet, se till att rättsstatsprincipen följs och att vardagen är trygg.

**Livskraft.** Målet är att Finland ska vara ett ledande land i fråga om internationell kompetens och innovationer. Den internationella tillväxten och en stark företagsamhetspolitik diversifierar näringsstrukturen och skapar förutsättningar för hållbar tillväxt.

**Förtroende och en jämlik arbetsmarknad.** Det är väsentligt att förbättra konkurrenskraften för företag med beaktande av de anställdas utbildning och kompetens, produktutveckling och investeringar, sysselsättningsfrämjande tjänster och uppmuntrande av företagande.

**Rättvisa och likabehandling.** Kärnan i välfärdsmodellen är likabehandling, välfärds- och utbildningstjänster, social rörlighet och det civila samhället.

**Kunnandets, bildningens och innovationernas Finland.** En höjning av utbildnings- och kompetensnivån, minskade skillnader i lärande och utbildningsmässig jämlikhet eftersträvas på alla skolstadier. Åtgärderna gäller hela utbildningssystemet och utvecklingen av det. Det görs satsningar på att förbättra förhållandena för forskning, utveckling och innovationer.



## 1 Introduction

The Government Programme of Prime Minister Antti Rinne's Government is designed to build a socially, economically and ecologically sustainable Finland. *Social sustainability* means we take responsibility for each other and our common future. Trust among individuals and also among different players in society is a key condition for building a socially sustainable society. A *sustainable economy* requires not only raising the employment rate but also boosting labour productivity. Finland's success depends on our ability to take advantage of the opportunities offered by change and to further develop the strengths we already have. An *ecologically sustainable* Finland will show the way in mitigating climate change and protecting biodiversity.

The Government has set four key economic policy objectives, which will guide government policy and implementation of the measures incorporated in the Government Programme's eight strategic themes.

- The employment rate will be raised to 75 per cent and the number of people in employment will increase by a minimum of 60,000 by the end of 2023
- Given normal global economic circumstances, Finland's general government finances will be in balance in 2023
- Inequality will be reduced and income gaps narrowed
- Finland will be placed on a path towards achieving carbon neutrality by 2035



In 2030, Finland will be a socially, ecologically and economically sustainable society

In its Programme, the Government makes the following pledges to citizens on policy reform:

- 1. Pledge for continuous learning in government
- 2. Pledge for a new kind of interaction
- 3. Pledge for long-term policy-making
- 4. Pledge for knowledge-based policy-making
- 5. Pledge for non-discrimination
- 6. Pledge for fair and equal treatment across generations

#### First Government Action Plan of the Rinne Government

This document is the first Government Action Plan of Prime Minister Antti Rinne's Government. It contains the key objectives and measures for the Government Programme's key themes, reaching across ministerial boundaries. It also specifies the particular ministries responsible for preparing and implementing the different measures. In addition to the Government Action Plan, there are other significant measures in the Government Programme, the implementation and monitoring of which will take place at ministerial level. The Action Plan does not replace the Government Programme in any way. The Government is committed to the spending limits system concerning central government expenditure. The measures in the Government Programme and other measures will be implemented to the extent possible within the spending limits framework.

## Monitoring and communication of the Government Action Plan

#### **Government evening sessions**

In joint evening sessions, the Government will regularly monitor and assess the current situation in the operating environment and the effectiveness of the measures included in the Government Action Plan with regard to the key strategic objectives. Based on its assessment, the Government will decide on the measures to be taken in the next phase.

#### Ministerial Committees and ministerial working groups

The Government has four statutory *Ministerial Committees*: the Ministerial Committee on Foreign and Security Policy, the Ministerial Committee on European Union Affairs, the Ministerial Finance Committee and the Ministerial Committee on Economic Policy. The Ministerial Committees play a key role in government policy-making.

The *ministerial working groups* appointed by the Government will guide the implementation of the Government Programme in terms of employment promotion, climate and energy policy, health and social services reform, competence, education and innovation, child and youth policy, and internal security and the strengthening of the rule of law. The ministerial working groups will be responsible, within the scope of their remit, for providing guidance on the preparation and implementation of the objectives and measures contained in the Government Action Plan.

#### **Effectiveness and communication**

The Government Programme's implementation and effectiveness will be monitored on the basis of the objectives in the Programme and using related indicators. The indicators will be made ready during autumn 2019. The Government will pay particular attention to the effects of decisions in the long term. Indicators that describe economic, ecological and social wellbeing will be used as an aid in decision-making preparations, alongside and in support of conventional economic indicators. A progress report on the Government Action Plan will be prepared approximately twice a year. An online platform will be used in monitoring the progress with implementation of the measures and objectives.

Progress on the implementation of the Government Programme will be communicated in accordance with the communication strategy adopted by the Government. The information will be presented in a transparent, interesting and interactive way, and, for the main objectives, the overall strategic messages will be summarised and a uniform visual identity created. Communication about the main objectives of the Government Programme, including the work of the ministerial working groups, will be directed by the Government Communications Department in the Prime Minister's Office, in close cooperation with the communications units of the other ministries and the Government Strategy Department of the Prime Minister's Office. This communications work will be reported to the Government on a regular basis.

# 2 Finland as a sustainable economy

The aim of economic policy is to increase wellbeing and prosperity. This means ecologically and socially sustainable economic growth, high employment and sustainable general government finances. A successfully operating welfare state, effective infrastructure, education, training, research and close integration with the world economy together form the foundation for Finland's economic success and growth. High employment requires a well-functioning labour market, an active employment policy, and access to the labour market for those with poor employment prospects.

Particular attention will be given to ensuring that the investment environment in Finland is attractive. We will pay careful attention to industrial competitiveness. The Government will encourage self-employment and entrepreneurship. Society must ensure that there are incentives for this as well as for businesses to provide employment. An ambitious, consistent and predictable climate policy will create a stable investment environment, which will present opportunities for Finnish business and employment.

## The key economic policy objectives for the government term:

- 1. The employment rate will be raised to 75 per cent and the number of people in employment will increase by a minimum of 60,000 by the end of 2023
- 2. Given normal global economic circumstances, Finland's general government finances will be in balance in 2023

- 4. The Government's decisions will put Finland on a path towards achieving carbon neutrality by 2035

# 3 Carbon neutral Finland that protects biodiversity

Finland aims for carbon neutrality by 2035 by accelerating emissions reduction measures and strengthening carbon sinks. The measures include new climate policy decisions, the production of nearly emissions-free electricity and heating by the end of the 2030s, reducing the carbon footprint from construction, promoting a circular economy and adopting a climate-friendly food policy. The deterioration in biodiversity will be halted by reforming the legislation on nature conservation, boosting the funding for biodiversity protection and promoting the sustainable use of biodiversity.

Housing challenges include the cost and shortage of housing in growth regions, and, by contrast, the numbers of dwellings standing empty and deteriorating in regions of net outmigration. In addition, construction and buildings together account for more than one third of Finland's climate emissions. Housing policy measures include securing sufficient residential zoning, implementing housing policy development projects and the Sustainable City programme, promoting wood construction and low-carbon construction, and launching a partnership programme for halving homelessness.

# 4 Globally influential Finland

Finland's foreign and security policy aims at strengthening Finland's international position, safeguarding its independence and territorial integrity, improving the security and wellbeing of Finland and its people, and ensuring that Finnish society functions efficiently. The main goal of our foreign and security policy is to avoid becoming involved in a military conflict. The promotion of human rights, the rule of law, democracy, peace, freedom, tolerance and equality in all international activities is central to Finland's foreign and security policy. The Paris Agreement and the 2030 Agenda, which lays down the sustainable development goals (SDGs), provide the foundation for international cooperation and Finland's actions in the coming years.

In terms of our external relations, the European Union is Finland's most important frame of reference and channel of influence, and a security community. It is in Finland's interests to strengthen the EU's unity and external ability to act. Implementation of the EU's Strategic Agenda adopted by the EU leaders in June 2019 will form the basis of Finland's EU action.

# 5 Safe and secure Finland built on the rule of law

Finland is the safest country in the world and we want to stay that way. Changes challenge us to better anticipate and prepare for the future. Finland must ensure internal and external security, respect for the rule of law, and people's everyday safety and security. Finnish democracy is based on the rule of law, with the Constitution giving every individual strong protection for human dignity, personal integrity and other fundamental rights.

The key challenges for the government term from the perspective of the rule of law are as follows: changes in the security situation and diversification of threats; increases in inequality and social exclusion; problems with the equal implementation of rights; maintenance of a sense of security; trust in society in general and good relations between population groups; and the operational capacity of the security authorities.

# 7 Finland built on trust and labour market equality

The Government aims to raise the employment rate to 75 per cent. At the same time, difficulties in labour availability and recruitment have nevertheless become an increasingly serious problem in various parts of Finland. The ageing of the working-age population and a lower birth rate also pose challenges for the Finnish labour market.

The transformation of work is bringing new kinds of issues that present legislation does not yet recognise. In addition, climate change has an impact on the world of work and occupational structures. Improving competitiveness is essential for Finnish enterprises and their employees, so attention is paid to employee education and skills, product R&D and investment, and services that seek to boost employment and incentives for entrepreneurship and self-employment.

It is also essential to increase the labour market participation of people with partial work capacity, of those with poor employment prospects, and of immigrants. There is still much to be done to improve equality and the quality of the world of work.

## **ANNEX**

The following are measures and steps set out in the Government Programme that involve preparation at parliamentary level:

- The reform of the Land Use and Building Act will be finalised through parliamentary preparations.
- In connection with the preparation of security reports, a parliamentary monitoring procedure with representation from all parties in Parliament will be organised in a manner laid down by Parliament.
- An act on a transparency register will be enacted based on parliamentary preparation and consultation of civil society.
- To further develop Finland's crisis management policy, a parliamentary committee will be set up to draft a comprehensive policy outline, extending over government terms, to systematically make activities more effective and to ensure better use of resources, and to make sure that participation volumes are sufficient.
- At the beginning of its term, Finland's new Government will set up a broad-based parliamentary committee to look into ways to develop general conscription and to meet national defence obligations.
- A parliamentary committee will be appointed to prepare a national strategy for children based on the UN Convention on the Rights of the Child.
- Separate from other preparations, a parliamentary committee will conduct preparatory work on the right of counties to collect taxes and the dismantling of multisource financing by the end of 2020.
- A parliamentary study will review the tasks of the National Supervisory
  Authority for Welfare and Health (Valvira) and the regional state
  administrative agencies with regard to the supervision, licensing and
  guidance of health and social services as well as the reorganisation of
  other tasks of regional state administration.
- The autonomous regions will enable a gradual transition to multi-sectoral counties. Preparations on this will be made in a parliamentary process by the end of 2020. A study will examine which duties of municipalities, joint municipal authorities and the state are to be transferred to counties.
- The Government will launch a reform of the social security system, which will build on the work carried out in connection with the Toimi project. A parliamentary committee will be set up to prepare the reform based on research information.

- We will implement a parliamentary reform of continuous learning, responding to people's lifelong need for upskilling and reskilling.
- In addition, consideration will be given to setting up a broad-based parliamentary advisory board to maintain awareness of the prevailing situation on international taxation issues and to monitor developments in international taxation and assess the impact of different proposals on Finland.
